NOTES

InsurancePlus coverage is based on a group policy which the card issuer has concluded with the insurance company AWP P&C S.A., Saint Ouen (Paris), Wallisellen branch (Switzerland) (hereinafter referred to as the "insurer"). The insurer and claims adjuster for all InsurancePlus claims is Allianz Worldwide Partners.

The InsurancePlus monthly premium is CHF 5 for the Credit Suisse Silver American Express Business and Credit Suisse Mastercard Business Standard. Irrespective of the invoicing/payment method selected (centralized or individual payment), the insurance premiums will be charged to each individual card with the monthly statement.

The complete terms and conditions of insurance are available at www.company-cards.ch or from the card issuer.

InsurancePlus coverage starts after checking of this registration form, the acceptance by the insurer of the date confirmed by the card issuer, and with the use of the card. Insurance coverage ends if the card contract is canceled in accordance with the General Conditions of the card issuer or if written notice of cancellation is given by the company or insurer. InsurancePlus can be canceled at any time by the company – not the cardholders – without affecting the card contract between the company and the card issuer or any other insurance benefits. Cancellation is possible at any time for all cards and takes effect from the date confirmed by the card issuer, normally one week after receipt by the card issuer of the written notice of cancellation. Premiums will be charged until this date.

Claims under InsurancePlus can be made solely against the insurer in accordance with the Conditions of Insurance; no claims may be made against the card issuer.

APPLYING COMPANY DECLARATION OF ACCESSION

In the name of the applying company (hereinafter "Company" or "We"), We declare that upon signature of this declaration of accession, all cardholders of the company account as detailed above register for InsurancePlus coverage in according with the insurance terms and conditions applicable to the individual card product. We have read and understood the insurance terms and conditions as well as the data protection provisions included therein and the resultant data exchange (especially Art. 11 in the General Conditions in the insurance terms and conditions) and accept them without reservation. We hereby authorize the card issuer, the insurer (including service providers) and other involved third parties with registered offices in Switzerland or abroad (including physicians, government offices, and other insurers) to process, share with each other, forward, or otherwise make accessible all information relating to the Company (or the cardholders) necessary for the conclusion and management of the InsurancePlus insurance, releasing them from any duty of confidentiality or secrecy. In particular, we release the card issuer from any confidentiality obligations to this extent and authorize it to disclose the fact that a card relationship exists between the card issuer and the Company (or the cardholders) for the purposes mentioned above. We agree to inform the cardholders, as well as any other insured persons, of this registration with InsurancePlus, the insurance terms and conditions, as well as the benefits included therein, the data protection provisions and the resultant data exchange (particularly Art. 11 in the General Conditions in the insurance terms

and conditions). We will likewise inform all cardholders, as well as any other insured persons, if we withdraw from InsurancePlus. The complete insurance terms and conditions and the information for persons insured under collective insurance can be consulted at www.swisscard.ch or can be requested from the issuer. The insurance terms and conditions are accepted not later than the first use of the card. The Company undertakes to provide the cardholders with the best possible support when making claims for payment.

The insurance coverage can be obtained as an associated service for the card. The card issuer brokers registrations to the collective insurance contract between the card issuer and the insurer. In addition, it carries out administrative work related to processing of the insurance coverage (e.g., management of the contract conclusions, premium collection, claims administration, statistics). The card issuer is reimbursed by the insurer for related personnel, technical (e.g., IT infrastructure) and other expenses in connection with the brokering and processing of insurance coverage. This reimbursement corresponds to customary remuneration for the services provided. The Company acknowledges the card issuer's claim to this remuneration paid by the insurer. The insurer alone is liable for errors, negligence, or incorrect information on the part of the card issuer in connection with the provision of InsurancePlus coverage.
